There are no special requirements in the above-mentioned regulation II-2/19 for the carriage of dangerous goods of classes 6.2 and 7, and for the carriage of dangerous goods in limited quantities, as required in chapter 3.4 of the IMDG Code, and excepted quantities, as required in chapter 3.5 of the IMDG Code.
3. Solid bulk cargo shall not be carried unless it is listed in the cargo list of Certificate of Compliance Required by IMSBC Code.

Remarks related to the information in previous table:

- 1.To be stowed at least 3m horizontally away from machinery space boundaries.**
- 2.To be carried in closed freight containers.**
- 3.Except dangerous goods for which "mechanically ventilated spaces" are required by IMDG code as amended.**
- 4.Stowage of class 4.4 liquids having a flashpoint less than 23° C is prohibited.**
- 5.Except dangerous goods having subsidiary risk Class 6.1.**
