- Class 2 - Gases : compressed, liquefied or dissolved under pressure
- Class 3 - Flammable* liquids
- Class 4.1 - Flammable* solids
- Class 4.2 - Substances liable to spontaneous combustion
- Class 4.3 - Substances which, in contact with water, emit flammable gases
- Class 5.1 - Oxidizing substances
- Class 5.2 - Organic peroxides
- Class 6.1 - Toxic substances
- Class 6.2 - Infectious substances
- Class 7 - Radioactive materials
- Class 8 - Corrosive substances
- Class 9 - Miscellaneous dangerous substances and articles, i.e. any other substances which experience has shown, or may show, to be of such a dangerous character that the provisions of this part shall apply to it.

* : "Flammable" has the same meaning as "inflammable".


Note :
